



With the end of COVID-19 emergency measures, MassHealth is returning to its annual renewal and redetermination process for all members beginning April 1. Mass Health will attempt to verify your information and determine your income eligibility. They recommend taking the following steps to ensure your continued coverage:

**Update your contact information.** Make sure MassHealth has your current mailing address, phone number, email and other contact information. You may do this by logging into your Massachusetts Health Connector online portal at <a href="https://www.mahealthconnector.org/">https://www.mahealthconnector.org/</a> and clicking Sign In.

You may also call 1-800-841-2900. You may also report changes to your income and family size, etc., through your portal and by phone.

Check your mail for a blue envelope. If MassHealth has trouble determining your eligibility, you will receive a blue envelope containing renewal forms in the mail from MassHealth. The forms need to be completed and returned, along with other documentation requirements. Failure to return the forms and documentation by the deadline may result in loss of health insurance coverage.

**TRENDS:** An in-depth review of my current caseload reflects the development of a trend with beneficiaries experiencing challenges with housing: private homeowners & renters alike.

Those renting are facing increased rents (4) as well as eviction (4). Some homeowners are having trouble paying their monthly bills (12). Though interestingly enough, I have several homeowners who are managing to meet their financial obligations each month (17). All 30 women receive financial assistance from the ARAW as well as from various community resources.

Of the 30, fifteen have been earmarked as potentially benefiting from a financial literacy program. Not by coincidence, this is the same group that is having trouble paying their monthly bills. Within my role as a BA @ ARAW, I have educated women about subsidized housing options (Senior Housing/Section 8) which is met with resistance. Homeowners say they will never leave their homes despite being increasingly in debt. Aware of the current housing market for apartments and the consequences of selling a home, I find myself grappling with solutions to assist these women. There clearly is not one simple answer though I do believe a few will engage in and practice handling of finances once provided the tools. However, that is the minority.

Many of the women endure mental health issues &/or cognitive challenges which create issues unto themselves. Some women lived their adult years with a higher economic income than their current situation and have not adjusted to the lack of cash flow. A few women have sounded a voice of entitlement that the ARAW should provide for their expenditures however they are unwilling to accept debt consolidation, money management or financial counseling programs.

As I review my beneficiaries, it is apparent that some women were dealt a better hand in life however those who are managing a bit better are those who have accepted and adapted to their current situation.

**Trends:** I have been noticing a trend in unsustainable living situations. Many women are struggling to pay their mortgage and monthly expenses yet unwilling to take the proper steps to alleviate their financial burdens; All for different reasons. And to add to this there is the housing shortage.

While as a Beneficiary Advocate, I can provide them with community resource that can alleviate some financial constraints, it is still an unsustainable situation. Not only is financial literacy so important, but so is the process for foreclosure and refinance process.

The unwillingness to face reality is also quite prevalent. These women are living in fear, procrastination, unrealistic expectations, yet hopeful. ARAW cannot solve their problems; we can only provide them with all known resources and empower them to follow through and be as informed and proactive as possible. My heart goes out to these women.

**GRATITUDE:** As a single mom and head of household I am so grateful to be able to be in my home and manage my monthly expenses. I can so relate to how the women I mentioned above must feel. I could not imagine having to give up a home I have worked hard to keep due to some unforeseen circumstances.

This is why I count my blessings to be a Beneficiary Advocate and part of ARAW. My role allows me to be informed of all resources and benefits available should I ever face what these women are living each day, and the ability to help these women is so fulfilling!

# LEAVE OF ABSENCE POLICY DRAFT | March 2023

A Board Member may request up to a one-year leave of absence (LOA) from the Board, before her term is complete. The decision to grant a LOA will be decided by Board vote. If a Board member misses three consecutive months of Board commitments, the President will contact the Board Member to discuss options for a LOA. The following applies to any Director on a LOA:

- The duration of a LOA is up to one year, at which time the Board Member can choose to rejoin the board or resign. A LOA cannot be extended.
- Upon return, the Board Member will finish the remainder of her term.
- The Board Member is not a voting Board Member for the duration of her leave.
- Any Board Member on leave is not counted when calculating a quorum.
- The Board Member will be copied on all board communications during her LOA.
- If the Board Member is a committee Chair then a new (or temporary) chair must be appointed by the Board President.

A meeting of the Grants Committee was held on March 24, 2023 for the purpose of considering requests by four of the grantees(partners) for extensions to roll over grant monies into the 23-24 year.

After thorough examination of the situation with each of the requests it was decided that an extension would be granted to New Bedford Art Museum and not approved for the Cape Verdean Association of New Bedford, South Coast LGBTQ, and Coastal Neighbors Network.
