The meeting was called due to the untimely passing of Treasurer Mary C. Ellis on August 6, 2023.

According the ARAW's by-law's Contingency Plan for Officer Succession, in the case of an unexpected "permanent vacancy of an officer of the Board . . . prior to her full term is satisfied," the "position left vacant will be filled by a member of the Executive Committee." . . . "In the event that no member of the Executive Committee is willing to serve in the vacant Officer position, per ARAW Bylaws, such vacancy may be filled by any of the Directors. The Governance Committee shall propose prospective Officers to the Board of Directors at a meeting at least one month prior to the meeting at which the election is to take place."

Given that every member of the Executive Committee declined to serve as Treasurer, Director and Finance Committee member Cathy Mayall has expressed her willingness to serve as ARAW Treasurer. Gale Beaton will present this information to all members of the Governance Committee for approval and formal nomination.

Jane Stankiewicz made a motion to propose Cathy Mayall for the office of Treasurer, pending a formal nomination by the Governance Committee. Second by Diane LaFlamme. All in favor.

TRENDS:

The ARAW has been a valuable resource in the area since 1866, however the significant role of the ARAW in the community is clearly being recognized by more organizations, agencies, and people within the Greater New Bedford area. With increased visibility, the assistance provided by ARAW is being sought by an increasing number of referral sources. Coastline case managers as well as Bristol Elder case managers are submitting referrals. Local COAs (Acushnet & Fairhaven) turn to the ARAW when they have a woman in need. ARAW beneficiaries are sharing their experiences with the ARAW and recommending their friends, neighbors or relatives call the ARAW.

The complexities of most referrals continue as the economic times worsen and psychosocial needs increase. Evictions, rent increases, harassment, mental health issues, loss of PEBT benefits, and discontinuation of the Foster Grandparent Program all contribute to creating significant challenges for our beneficiaries and new referrals. As noted in previous monthly reports, more time is needed to sift through multiple layers of concerns & findings to obtain the most accurate application. In early 2022, I seldom carried over requests from month to month. Currently, I have 6 being carried over to July as I gather needed information for the Board to make an informed decision.

Financial literacy education is a MUST. Where to find? Who can provide? How can this be implemented? Many of our beneficiaries lack the basic skills of budgeting and continue to struggle with finances. With limited incomes and soaring prices in groceries, fuel, rent etc. understanding how to maximize resources and minimize expenses is vital. Credit card debt in not uncommon and I foresee an increase in utilization by many women as the economy shifts. Of interest: A current beneficiary who is a homeowner has struggled with her finances for years. Money management & debt consolidation as well as Judgement proof were all discussed with her. She began to consider a reverse mortgage but her family dissuaded her. She sought assistance from her COA Outreach Worker who once again suggested the CES Money Management Program. Except this time the program was introduced as Financial Advising. The beneficiary accepted the service and has a monthly meeting with a volunteer to work on her budget. The power of words!! Going forward, I too will suggest a Financial Advisor from CES.

CHALLENGE(S): I worked on a case involving one of my Beneficiaries that highlighted how difficult it is to navigate the healthcare system. The Beneficiary had requested support from ARAW to purchase a PureWick External Catheter system. She had just been discharged from the hospital and during her hospital stay she was able to use this system which provided her with many restful nights' sleeps. She has had urinary incontinence since the birth of her son approximately fifty years ago.

Unfortunately, the system is expensive, and the monthly catheters alone are \$200 (30 per month). I informed her that she would have to do some research herself and find out if her insurance would cover the system and catheters. She then also mentioned that she doesn't understand why she has such little PCA hours given her poor health. I again encouraged her to contact her Case Manager and find out what could be done.

After a few weeks, she called me very frustrated because no one was getting back to her with answers. I told her I would assist her and call her case manager and see if I can assist in getting her needs resolved. While my interaction with her case manager was pleasant, I could tell the case manager wasn't seeing her situation as a priority. So, I decided to do some digging.

- 1. Her health insurance was switched from Senior Whole Health (SWH) to United Health Care (UHC) due to her PCP no longer contracting with SWH. This happened in 2022 and caused her PCA hours to be drastically reduced.
- 2. The PureWick system is not covered by UHC, however, it is not only covered by SWH, SWH also provides a much higher increase of hours for her PCA services. Additionally, she needed to find a new PCP that contracted with SWH.
- 3. She was able to find a doctor (Dr. Dirician) who makes home visits and would be willing to work with her on getting the PureWick system processed and paid for through SWH.
- 4. I connected her with a SHINE counselor through Coastline and effective August 1st she will not only be enrolled in SWH, but she will also have increased PCA hours and most likely the PureWick system covered as soon as she books her initial PCP home visit.

I am sharing this story to show that there are times when we must do so much more than we report to the Board. While I cannot do this for everyone on a regular basis, in special circumstances like this one it requires more effort to advocate when no one else would or maybe could or want to.

TRENDS: This month the importance of FLO and the Partnerships came to light. In speaking with several beneficiaries in the past weeks, the significant impact that these programs bring to the table was highlighted. I would like to share two positive experiences with you.

VC was guarded with her personal information when we first met in November of 2021. Gradually, as a trusting rapport developed, VC began to share more details of her life including the deaths of both her children. During a recent home visit, VC shared that she was being harassed by a male tenant in the complex. She had reported these ongoing incidents to the property manager as well as to the Acushnet PD who recommended she obtain a restraining order. VC admitted to being afraid to pursue this legal action. SCCLS was discussed as an option for VC and she called them the following day. Due to a conflict of interest, SCCLS could not represent VC but did provide her with 3 resources. A call to the Justice Bridge connected Vanessa to an attorney who assisted VC through the court proceedings. Unfortunately, the second judge did not grant the restraining order. Rather, he verbally instructed the male to "stay away from Ms. C." VC told the judge that "clearly the judicial system's method of treating women had not changed in the past 30 years!" VC shared she needed protection from a former spouse years ago and the system had failed her as they did once again in her eyes. She now sits at her window to watch when this individual leaves the premises. It is at this time, she will venture out to the gazebo, to get her mail, to do her laundry. And yes, he has continued with making his presence known to her. She has filed once again with the Acushnet PD. VC states that "the saving grace in all this has been my friends and the NBAM art classes on Sundays! I can't begin to tell you how the art classes take me away, out of my head and into my imagination. For a few hours, I relax and breathe. Thank you SO much for everything. I am looking forward to the Harbor tour. I have always been afraid to go anywhere by myself, but I am learning that the ARAW women are like me, alone and in need of companionship. Plus, everyone I have met is so nice. I can ever thank you enough."

TDM has struggled with mental health issues for most of her life. A bitter divorce from an abusive spouse, dysfunctional relationships with her family, and alienation from her children leave TDM with minimal social support. "I haven't had it easy in life. But I look forward to the Wamsutta Luncheons with the ladies. It is a chance for me to be with other women, to laugh, to forget about my problems. I love getting dressed up. It makes me feel special. I have missed outings due to my health, but I am determined to attend this month! Thank you All."

Gratitude: I would be remiss if I did not take an opportunity to address the void felt in our community with the recent loss of our beloved Mary Ellis. Mary displayed her kindness and compassion by always making time to say Hello to me before a meeting. I will always remember her beautiful sparkling eyes which I believe displayed a bit of mischief!! My only regret is that I did not get to know her better and to introduce her to my menagerie of animals on my Farm... Due to the recent birth of my Grandson, I was unable to attend Mary's service which I understand displayed an outpouring of love and admiration for a remarkable woman.

This month I have taken on a total of (12) referrals and the one trend I noticed is that many of the referral sources have referred to ARAW this month as more of a provider of resources. There is no clear need, however, they refer to ARAW to link people to appropriate community resources.

Here are some of this month's referral requests:

- **Support for bed rails**: This is covered by insurance through the assistance of a physical therapist and the primary care physician.
- **Support for appliances and linens**: There are other community resources they should be aware of, such as, My Brother's Keeper, Fresh Start, and Walt's Mobile Closet, Coastline's Little Necessities and Discretionary funds.
- Hoarding concerns: Fresh Start has a hoarding Workshop in Fairhaven and New Bedford.
- **Medicare Part B assistance**: SHINE counselors are located at all COAs are the experts to assist in these matters. SCCLS can potentially assist in reduction or distribution of the late sign on fees.
- Start up Funding for Art Classes: I referred to NB Art Museum and it was declined. No other financial hardship identified.

Another noted trend is as word is getting out about ARAW, women who have never asked for help before are reaching out and in unsustainable financial hardship for years. I have three very similar complex cases with thousands of dollars in credit card debt, unable to make monthly expenses or pay mortgage, property taxes or insurance without cashing out life insurance policies or placing these expenses on credit cards.

I will say that two out of the three women are diligently working with the resources I provided them, such as, ACCS, SNAP, PACE, Foster Grandparent Program, SCCLS, and Walt's Mobile Closet. The other kindly kicked me out because ARAW wouldn't just pay her outstanding mortgage so she doesn't go into foreclosure, and she would figure out her unsustainable situation a day at a time going forward.

I will say, on a positive note, these cases are teaching me what not to do, and the resources that are available should I find myself in a similar situation. I am very grateful to be able to help these women, especially the ones that are so appreciative of the help. I am confident that most will find themselves in a manageable situation soon.

This meeting was held at the request of the Finance Committee in order to have a presentation, review and discussion of the 2023 Financial Statement Draft as prepared by our accountants, Burke and Lamb.

As noted at the last meeting, some of the specifics and highlights are included in the Statement. In order to gain a greater insight into how the accountants developed details (unrealized loss, investment income, liquidity as it may affect fundraising) committee members had the opportunity to ask questions for clarity and greater understanding.

The Finance Committee agreed we are prepared to present the Draft 2023 Financial Statement to the entire board for a vote to approve and accept. This will be done at the July 13, 2023 meeting.

As a wrap-up discussion with the accountants, we discussed why we are currently not required to have full financial audits. Our recent and current financial stability and performance would not require an audit. It would be a costly and time-consuming process when a Financial Statement meets regulatory requirements. Changes that could move us to audit mode might include ED/major staff changes; large gifts; revenue greater than \$500,000; any decision to pursue obtaining a grant(s); or plans for a capital fundraising campaign. As long as we are aware of these possibilities as future triggers, we can continue with plans laid out in our most recent Strategic Plan.

Sincere thanks to all who were able to add this unscheduled meeting to their calendars. And a special thanks to Peter and Michelle for their time and insight. It is always helpful to meet in person with our knowledgeable vendors.

FINANCE COMMITTEE MEETING MINUTES

JOINT MEETING WITH B OF A AND INVESTMENT ADVISORY COMMITTEE

JULY 26, 2023 | 9:30 AM

Per our goal established last year, this meeting was in-person with our Finance Committee, Investment Advisory Committee, and Bank of America portfolio management team. Its purpose was to review portfolio performance of the first quarter of our fiscal year (and second quarter of the calendar year).

Portfolio Review (copy available upon request)

Sarah (BOA) reviewed the key points of the portfolio review – highlighting individual performance, global performance, and expectations of future markets. Value of our holdings as of 6/30/23 is \$19,651,080 with a 4.3% quarterly return, and a 12.66% return for the year (net of fees), with both outperforming the benchmarks. The distribution is equities 69%, Fixed 15%, Hedge 13% and cash 3%

The primary drive of growth and profits was artificial intelligence, with energy, lab science, health care innovation and robotics. The "Magnificent 7" was responsible for 73% of the growth. Magnificent 7 = Apple, Microsoft, NVIDIA (artificial intelligence), Amazon, Tesla, Meta and Alphabet (essentially google).

Looking Ahead

The expectation is of a mild recession to begin at the mid-half of 2024. Feds are expected to increase rates again on 7/26/23, and follow with one more increase. Once the rate hikes stop, the interest rates may come down, but market volatility is expected.

Sarah discussed the effects of inflation. Homeowners have been in a good position, as not affected by increasing interest rates, yet "renters" have watched their rental rates rise significantly. Travel is booming. Consumers are still spending. However, how long will that last...student loans will again need to be to be paid, baby boomers will be selling houses at higher interest rates, etc. Tech companies have "hoarded cash" and have strong balance sheets, but will their earnings keep up with inflation? Flat growth is the expectation of 2024.

Our current portfolio is well diversified. The opportunities will come via long-term strategies. The US is the preferred equity region due to volatility, though geopolitics will play a significant role in the markets – the upcoming US elections, Taiwan, China, Ukraine.

The recommendation was to make no significant changes at this time.

Other Issues-

Clare brought up the issue of inconsistency between the documented investment income between 3/30/22 and 3/30/23- \$760,696 and \$462,325. The IAC was surprised by the \$760,696 of 2022. This issue will be analyzed further, and the results will be reported back to the committee.

These minutes are a distillation of a detailed and informative meeting in which participants were engaged, thoughtful, and helpful. Such quarterly reviews in the year to come promise to bring further understanding of the global banking world and ARAW's portfolio stability.
